- 1. The By-Laws of the organization were amended on February 1, 2000, and state that the positions of President, Vice President, Recording and Corresponding Secretaries may be held by up to two or more persons acting as co-officers. The Treasurer position may be held by only one individual.
- 2. All positions are currently available for next year. Every year, each position, whether running against an incumbent or a vacated seat, is available to run for. If a position is being run by two or more people who do not wish to seek a co-position, an election will take place at the final PTO meeting of the year. If the race is uncontested, the nominating chair will read off the names of those "elected" for the next years board for minutes to reflect accordingly.

- 3. The positions accepting nominees are: President(s), Vice-President(s), Treasurer, Co-Recording Secretary, Co-Corresponding Secretary.
- 4. Your nominations should be made in writing and sent in a sealed envelope to the: Nominating Committee, Rydal East Elementary School, Attn: Rishona Myers. ALL NOMINATIONS MUST BE RECEIVED BY April 17, 2024.
- 5. In the case where no candidate has been named in advance, nominations may also be made in person at the April 2024 PTO meeting, which will be held at 7:00 pm in the Café at Rydal East Elementary School.
- 6. You may nominate as many candidates as you like on the attached form. One may also nominate themselves for a position. In order to avoid nominating individuals who are unable to serve, we ask that you kindly contact the prospective nominee to inform them of your intention to nominate them and to obtain their agreement.
- 7. After all nominations have been received, the nomination committee will determine if it is necessary to prepare the slate of nominees, along with some brief biographical information on each nominee. This will be distributed with information regarding the voting process to all PTO members who have paid dues, two weeks prior to the May 22, 2024 PTO meeting. In the instance where only one candidate has been named, this step will not be necessary as the candidate becomes the presumptive nominee.

Ballots will be distributed no later than 2 weeks before the May 2024 meeting and must be turned in 2 days prior to the May 2024 PTO meeting. A vote and tally will also take place at the P.T.O. meeting on May 22, 2024 at 7:00pm in the Café at Rydal East Elementary School. Ballots will be confidential, and will be counted by a neutral party appointed by the Nominating Committee.

Again, we hope that you will take part in this important process. If you have not yet paid your P.T.O. dues for this school year and would like to participate in the election, please attach your check, in the amount of \$25.00 payable to the Rydal P.T.O., to the Nomination form.
